Voters' roll in a mess despite election callMugabe expected to raise the dead to secure victory

DESPITE calls by Zanu PF leader Robert Mugabe that elections to replace the ailing inclusive government will be held next year, a glance at the country's voters' roll is a cause for concern reigniting calls for a fresh electorate list.


Zimbabwe has the highest proportion of elderly voters in the world, according to the voters' roll that was used for the harmonised elections in 2008.

Zanu PF has in the past manipulated the voters' roll to such an extent that some people who are long dead have been able to cast ballots from their graves and Mugabe has succeeded to do so because it is in shambles and he simply takes advantage of the confusion.

Before the last elections, in 2005, the MDC was able to get hold of CDs of the voters' rolls for 12 constituencies, subjected them to digital analysis and found that 45 per cent of the names on the list were false. Since then Tobaiwa Mudede, the Registrar-General, has kept a tight lid on the roll.

An audit of the voters' roll conducted by the Research and Advocacy Unit of pressure group Sokwanele unearthed several anomalies in the current voters' roll maintained by the Registrar General's office.

These include a surprisingly large number of people aged 100 and above. The audit identified names of 74 021 voters aged

above 100 on the roll used in last year's harmonised parliamentary and presidential elections. There were also 82 456 people registered who are aged between 90 and 100, according to the report released at the weekend.

"These figures are quite amazing when you consider that average life expectancy in Zimbabwe is 34 for women and 37 for men, and in light of the fact that the World Health Organisation predicts that only 14.7 percent of people live beyond 60 in Zimbabwe," the pressure group observed in a report titled "2013 Vision – Seeing Double and the Dead".

Meanwhile, the Zimbabwe electoral Commission (ZEC) chairperson Justice Simpson Mutambanengwe has said that the commission is not there to effect regime change, but to deliver, free and fair election.

"ZEC is not there to cause regime change as such. If regime change occurs, it is simply an incident of our work. We are here to deliver a free and fair election that is credible to all parties involved," Mutambanengwe said addressing a workshop in organised by The Zimbabwe Election Support Network last week.

"As part of improving the country's

electoral systems, ZEC would consult with stakeholders to come up with ways of improving the voters' roll," he said.

A source told a local newspaper that members of ZEC are undergoing secret training at Central Intelligence Organization (CIO) offices across the country, allegedly in order to manipulate the running and outcome of future elections. An unwilling participant at the course told the paper that training began on Monday at Hurudza House, the CIO Mashonaland East Provincial headquarters.

"Though the training was still in its initial stages, the aim of the exercise was obviously for us to learn new tricks and methods of manipulating election results without raising public eye-brows," said the

ZEC deputy chairperson Joyce Kazembe surprised many last week when she said that the electoral body was ready to conduct national elections and only required the requisite proclamation from President Robert Mugabe in his capacity as Head of State despite the fact that the voters roll that has been used since independence in 1980 has not been revised.

This was after Mugabe last week indicated that a referendum for a new constitution will be held in the first quarter of next year while elections would follow by mid-2011.

Green bombers resurface in time for elections

THE dreaded Zanu PF youth militia, graduands from the national youth training service institutions also known as the Green bombers have resurfaced just in time for the 2011 plebiscite that is being called for by Zanu PF leader Robert Mugabe.

The re-emergence of the youth militia nicknamed the green bombers because of their green attire has sent shock waves among Zanu PF's arch rivals especially the two MDC formations, the one led by Prime Minister Morgan Tsvangirai and the smaller faction led by Deputy Prime Minister Arthur Mutambara.

Sources close to The New Age Voices say that the militia will be called on to beef up the Zanu PF youth wing that will be expected to be unleashed on the electorate again after the unforgettable June 27 one man runoff election.

The youth militias are well-trained in torture techniques which they use on civilians who refuse to identify with Zanu PF ideology. The Zimbabwe Republic Police take virtually no action against the forces, widely feared for their reputation for

The thugs are trained in six-week sessions at four camps established by the government. Ostensibly they are doing their "national service" and learning skills to help the community, but they are renowned for torturing, raping and killing opposition activists.

It has been nine years since the launch of the Border Gezi program, with an estimated 80,000 graduates who have been turned into Zanu PF security agents.

Recently the deputy Minister of Youth, Indigenisation and Empowerment Tongai Matutu told The New Age Voices that the militia training had been halted but this paper was taken by surprise when the unilaterally appointed Masvingo Governor Titus Maluleke officiated at a pass out parade of 100 youths from the Border Gezi youth programme at Mushagashe Vocational Training School last week. Matutu boycotted the graduation ceremony.

In an interview with The New Age Voices recently, Matutu said that the youth training programme has been put on hold because it was not properly set up.

He said that since the inception of the Inclusive government, the programme was suspended as government was having a relook and how to properly structure it.

He said that it should be the desire of every youth to join national youth training service because of what it offers as value addition to an individual and not a situation where youths are coerced to join.

"You see there is a problem with the set up of the programme. It should come from someone's heart that he or she wants to

join the youth service. The situation of forcing people to join is disastrous," Matutu said.

The re-emergence of the terror troops is expected to tilt the vote in favour of the hugely unpopular Mugabe who remains in power at the mercy of the Inclusive Government because of its ability to instill fear on the electorate.

In 2007, Members of parliament, including some from Mugabe's Zanu-PF party, toured several national youth service camps and vocational training centres, which are also government- funded and were horrified at what they found,

dilapidated dormitories, minimal food rations and females sexual abuse.

The youth militia is taught exclusively ZANU-PF campaign materials and speeches. These include an anthology of Mugabe's speeches titled Inside the Third Chimurenga. The speeches glorify Mugabe's land reform programme and ZANU-PF heroes Border Gezi and Chenjerai Hunzvi.

The national youth service was authorised in 1999 and established in 2001 under the presidency of Robert Mugabe and has since been used to prop up Zanu PF violence.

Jabulani Sibanda Masvingo terror intensifies

THE controversial self styled war veteran and Zanu PF member Jabulani Sibanda has upped his terror campaign in Zaka and Bikita districts and has virtually camped in the province where he is churning out party propaganda and threatening villagers with violence.

Sibanda has for the past 3 months causing havoc in Masvingo province where he is moving around with Zanu PF youth militia that unleashed an orgy of violence in the run up to the discredited June 2008 runoff election that saw Zanu PF leader Robert Mugabe compete in a one man election after Morgan Tsvangirai pulled out citing the youth's violence.

Information gathered by The New Age Voices last week revealed that Sibanda is force marching people to attend meetings where he is indoctrinating people on the Zanu PF ideology and at the same time threatening the villagers whom he is accusing of dumping Mugabe in favour of Movement for Democratic Change (MDC) led by Prime Minister Morgan Tsvangirai.

Villagers say that Sibanda has virtually relocated to Masvingo province and that he is frantically trying to change the hearts and minds of the people there through instilling fear on them by threatening to unleash another orgy of violence that will


surpass the 2008 runoff levels.

Sources in Zanu PF say that the war veterans leader has been tasked by Zanu PF with turning around the fortunes of the party through using guerilla tactics that have failed to bring success to the party for the past 10 years.

Given the 2011 plebiscite that is expected mid next year, Zanu PF is desperate to wrestle back control of the government and parliament especially in the later where it has played second fiddle to their more illustrious MDC-T counterparts.

Last week tempers flew in parliament with members of parliament from MDC-T and Zanu PF exchanging harsh words over Sibanda's presence in the province. MDC-T MPs have demanded that Sibanda be removed from the province because he has caused untold suffering on the people of Zaka and Bikita districts.

Last month, Mwenezi East Zanu PF Member of Parliament Kudakwashe Bhasikiti threatened villagers in a Zaka Ward 24 Constitutional and Parliamentary Select Committee (COPAC) outreach meeting with violence after they moved a motion to ban aged politicians from contesting in elections. The meeting was held at Mushungwa primary school.

A day before the outreach meeting at the same venue, Zanu PF and War Veterans held a pre-outreach meeting that was poorly attended which was meant to rally villagers to support the Zanu PF stance in the constitution.

However, the meeting was held contrary to COPAC regulations prohibiting political gatherings 24 hours before outreach meetings. The meeting was chaired by retired Army Colonel Livingstone Chineka who is the former MP for Zaka East.

Sources who spoke to The New Age Voices said that Chineka organised night vigils and door to door campaigns that were meant to align people with the Zanu PF position but villagers in the area defied the intimidation and thronged the venue in droves.

Opposition parties have slammed the latest Zanu PF stunt saying it shows that the party has failed to reform despite spending time in the Inclusive Government.

Admin boobs expose COPAC

WHILE the country is still trying to come to terms with the circus that took centre stage as the constitution making process climaxed with violent meetings in Harare, the Constitutional and Parliamentary Select Committee (COPAC) continues to hog the limelight for the wrong reasons.

The COPAC management committee has incessantly postponed the Harare outreach meetings that were suspended almost a month ago after Zanu PF youth militia unleashed an orgy of violence on civilians who had come to contribute ideas forcing rapporteurs to abort canvassing.

Information obtained by the *New Age Voices* last week revealed that COPAC is failing to raise US\$268 000 that is required to conduct the aborted 42 outreach meetings in Harare.

Although lipstick attempts have been made to reach out to the Diaspora, COPAC has failed to adequately cater for the exiled citizens many of whom flew political and economic upheaval that has engulfed Zimbabwe for the past decade.

COPAC has also been found wanting in terms of logistical arrangements that have led to internal chaos thereby affecting the outreach process. The New Age Voices takes a closer look at some of the bungling of the COPAC management committee.

The New Age Voices can confirm that over 30 COPAC outreach team members and rapporteurs stormed the body's headquarters in Milton Park over two weeks ago demanding outstanding allowances.

The outreach members, who came from Mashonaland Central and East provinces, arrived at the headquarters at around 8am and broke into song and dance.

The angry mob allegedly assaulted security personnel at the main entrance and closed the gate before declaring that no one would be allowed to enter or leave the premises until their grievances had been addressed.

Police had to be called to disperse the marauding mob at around 10am. COPAC co-chairperson Mr Douglas Mwonzora confirmed the incident and said the aggrieved members were addressed by Mr Gift Marunda, the project administrator and finance manager, before they were paid their dues on the same day.

"We still need the services of the team members. As you are aware, there were disturbances in Harare at about half of the places the outreach programme was being held, a development that has been condemned by the three principals to the inclusive Government," said Mr Mwonzora.

Only Last month, MDC-T's House of Assembly member for St Mary's Mr Marvellous Khumalo and 10 other party members brought business to a halt at the offices, again demanding their allowances.

In July, Members of Parliament stopped participating in the constitutional outreach programme citing low and erratic payment of allowances.

"Some Members of Parliament and outreach members left the programme. We did not inquire the reasons for their pullout because this is a voluntary programme and anyone can move out," Mwonzora was quoted as saying then.

Mr Mwonzora refused to name the legislators. The legislators said they could make more money doing their own things in Harare than by going on the outreach.

The MPs also tried to coerce support staff into going on strike in a bid to have their conditions of service improved.

We are operating under very difficult conditions characterised by late payments of the allowances while accommodation is difficult to secure in some areas.

"Some have resorted to asking drivers and other support staff to strike so that all our grievances are addressed," one source said.

Also last month, drivers employed under the constitution-making process in Matabeleland South temporarily downed tools demanding their outstanding salaries.

The disgruntled drivers refused to take COPAC outreach teams to venues of their meetings, leaving the teams stranded in Bulawayo.

COPAC co-chairperson Edward Mkhosi confirmed the strike by the drivers and said the drivers were demanding outstanding salaries they said have not been paid for a long time.

Mkhosi said the drivers' reasons for going on strike were genuine and needed to be dealt with amicably.

"The truth is that we are all waiting for money from Treasury, including drivers and members of the outreach teams. They are still owed some money, but the truth is that right from the top person to the lowest, we are all owed money by COPAC," Mkhosi was quoted as saying.

It is such disorganisation by COPAC that critics say exposed the inability of the committee to effectively discharge its duties which eventually culminated into chaos in Harare.

Zim youths set for climate change conference

TWELVE Zimbabwean youths are set to leave the country next month for the youth climate change conference that will be taking place in Malawi from the 17th to the 19th.

The Southern and East Africa Youth Conference on Climate Change (SEYCCC) will be held in Lilongwe and is set to bring together youths from across the southern and eastern part of the continent. The theme for the climate conference is, "Building capacity for climate change interventions in Southern Africa: Adaptation, mitigation and advocacy".

The conference will bring together over 500 young activists who have a passion

for climate change. Action 24 is coordinating the event and has brought together 12 youths from various organisations in Zimbabwe who are dealing with climate change issues in their fields of expertise.

The youths have organized a road trip to Lilongwe where they will take the opportunity to move around educating the communities on the effects of climate change in their communities and would also lobby the communities to embrace ways of countering climate change such as planting trees.

Lewis Makurumure Coordinator for Action 24 who is also one of the facilitators

of the trip said that the road trip will afford the participants the chance to conscietise people on climate change scourge.

"The purpose of the road trip will be to enable the team to disseminate information on climate change in the communities enroute to the conference. It will also raise awareness on the impact of climate change on the communities and how they can counter it," Makurumure said.

The team is in the process of sourcing trees that they will plant on the road trip while distributing some to the communities and expect members of the communities to take a leaf from their awareness activities.

The youths will also be cycling in

some of the communities on their way to Malawi to enable them to interact effectively with members of the community and distribute campaign materials such as fliers and pamphlets.

The youthful team will present a position paper at the conference on the state of the country's ability to tackle issues around climate change such as mitigation and adaptation, advocacy and policy.

The initiative by the youths has been hailed by environmental leaders who have said it sends the right signal because the future belonged to them and hence they should play a leading role.

UKUBAMBANA YOUTH DECLARATION

ON PEACE AND NATIONAL HEALING

Agreed on this 24th day of September, 2010 at the Ukubambana Youth Peace Summit.

PREAMBLE

We, the young people of Zimbabwe, gathered under the auspices of UKUBAMBANA YOUTH PEACE SUMMIT Convened by the Zimbabwe Youth Organisations Network (ZIYON) from the 21st to 25th of September 2010

Commemorating the 2010 International Day of Peace, Desirous to witness the realisation and sustenance of true and lasting peace in Zimbabwe Committing ourselves to be part of the Zimbabwe Peace Process and the national healing process Convinced that true national healing can only be achieved through addressing several multiple issues which threaten social stability such as health, governance, economic, social, gender, cultural issues among others Hereby make the following demands and commit ourselves to the following:-

COMMITMENTS

1. We commit ourselves to be agents and ambassadors of peace, shunning and rejecting violence and further

commit ourselves to initiate and take part in all peace related efforts at individual, collective, community, societal, national and international level. 2. We commit ourselves to active and constructive engagement in the economic, social and political processes at all levels. We further commit ourselves to upholding an ethos of transparency and accountability, shunning corruption and apathy.

3. We commit ourselves to peaceful participation and constructive engagement with all stakeholders for the realisation and advancement of our fundamental liberties and rights, including but not limited to gender, health, academic freedoms and all socio-economic and cultural rights.

4. We commit ourselves to the promotion of a peaceful and tolerant political and electoral environment to sustain national stability, prosperity and attainment of meaningful and participatory democracy.

5. We commit ourselves to contribute meaningfully to the national healing processes, and further commit ourselves to reject being used as agents of violence in our nation.

DEMANDS

1. We call upon the Government of Zimbabwe to engage in broad based consultation with the youth, towards the implementation of a voluntary, non militarised and non partisan youth training programme for the purpose of imparting critical life skills to the youth, through the school curriculum.

2. We call upon the Government to implement policies and adopt laws,

supported by the necessary administrative and technical infrastructure to enhance the economic development, empowerment and emancipation of the youth.

3. We call upon the Government to adopt specific, measures to ensure that state institutions and state machinery are not manipulated by any state and non state actor for the purposes of intimidation, ruthless

suppression of dissent, violence or stifling the voice of the youth. We further call upon the Government to ensure that State institutions and state machinery will serve and not subvert the will of the youth through a specific pro-youth regulatory framework of these state institutions and other state machinery.

4. We call upon the Government of Zimbabwe to institutionalise and set up an independent constitutional youth body which shall be responsible for capacity building of the youth, impartation of life skills, youth leadership development, the realisation of a quota representation of youths in government, policy formulation and implementation, decision making, as well as administering over the affairs of the youth, including a special fund for the youth for these purposes.

5. We call upon the Government of Zimbabwe to establish a conducive and enabling political environment to enhance positive youth participation in the political processes, including but not limited to the electoral process, non partisan state media and non partisan state security forces.

We will remain resolute: Tafadzwa "Twoboy" Mugwadi

EVER since the Rhodesian discriminatory education system under the stewardship of Ian Douglas Smith, Zimbabwe's tertiary education system has never been in murky waters that it finds itself in at the moment. The Zimbabwe National Students Union (ZINASU)has struggled to stay afloat in a highly contagious political environment which saw it splitting into two factions, one then led by Clever Bere and the other one by Brilliant Dube. The leadership that took over both factions, although they tried to find common ground, continue to operate separately. The Editor of The New Age Voices, Francis Rwodzi (FR) caught up with ZINASU faction leader Tafadzwa "Twoboy" Mugwadi (TM) who spoke at length about the challenges faced by the union and the way forward for students among other issues.

FR: Twoboy thank you for coming through for this interview but I must confess that it has not been easy because there are two factions here.

TM: Let me categorically state that there are no factions in ZINASU, there is only one ZINASU headed by me. I only get to hear about factions in newspapers and when I chat with colleagues and when I get interviewed by journalists like you. On the 18th of June 2010, the ZINASU leadership sat down in a historic extraordinary general council and resolved to have unity of purpose Vis a Vis the farce that was taking place at St Lucia Park. Today we are beginning to see the fruits of the unity that is backed by overwhelming support which has been our pillar of strength. We now stand proud that we are united in pursuit of academic freedoms that will see tertiary institutions being transformed from institutions of higher learning, to institutions of higher earning.

FR: What have you done as ZINASU to ease the plight of students in tertiary institutions especially those who are not paid up?

TM: Firstly let me say that ZINASU is not a state policy maker, we are only a lobbying movement that seeks to influence policy makers to also remember the plight of the students. In this regard, we have met the Prime Minister Morgan Tsvangirai bilaterally and in particular on the sidelines of the May day celebrations. Let me quote what he said, "I am going to address this in 20 days and we will meet (Stan) Mudenge and take him to task," I am not sure about the PMs definition of 20 days which goes beyond 5 months. We had requested that supplementary

examinations be provided for those students but the government remained adamant. In the same way, we have lobbied government to address the challenges of accommodation where the halls of residence continue to be incessantly closed for reasons only rumoured in newspapers which are not realistic. Let me put it very clearly that students cannot learn without accommodation which is a basic right for any scholar, these are the things that we want addressed so that no student is prejudiced.

We are also lobbying for the disbandment of semesterised student cards which are meant to victimise poor students who are prohibited from accessing lectures and library facilities on the account that they have not paid.

FR: What has ZINASU done to help expelled and suspended students back to class?

TM: The suspensions and expulsions are enough evidence that it has not been thawing or raining but it continues to pour for the hapless students. We need to restore some level of sanity. The Students Solidarity Trust had the responsibility of taking care of these activists because some will be disowned by their families. The SST has abandoned that, we are now seeking to engage new partners and open new avenues for our activists. We are happy that some of the students were awarded the Libertas scholarship to study in The Netherlands. Most funders have been concentrating on the constitution making negating the social security side in terms of students. We are happy that those who were expelled continue to partner us. What they fought for will one day be rewarded.

FR: What is your position on the 2011 election that is being called for by President Robert Mugabe, as students?

TM: It is very unfortunate that politicians rush to talk about elections before even stopping to ask whose election it is anyway? You cannot talk of elections when we have POSA, instruments that close democratic space for a free and fair election. The union is worried, who doesn't know that this country was marred by chaos in the run up to June 27 elections? There is need for legislative reform to create a conducive environment. Let me warn you that nothing has changed since 2008, Zanu will lose the election but will not leave power. The police, ZEC, the military and the judiciary have not yet been reformed. ZINASU is going to sit down and chat a way forward in as far as those elections are concerned. We are going to embark

on voter registration mobilisation campaign for students to register.

FR: From the students' perspective, how has national healing process fared?

TM: The national healing process is a national blunder. It was not supposed to be full of political appointees. What is the role of the church? What is the role of civic society? The co-ministers need healing among themselves. The civic society and church have not been given roles that they deserve. Zanu has caused the majority of the wounds and it is continuing to rub salt on the wounds. As we speak, Jabulani Sibanda is terrorising people in Masvingo. The problem that we have is that the victim is ready to heal but the perpetrator is reluctant, Sibanda's actions are enough testimony. It is unfortunate that the organ is squandering taxpayers money, it should be disbanded and replaced with the church, civic society and retired judges. People should return things that they stole, those who killed must be arrested. Who does not know that Ndira, Chiminya, Chokururama, Kauzani among others were murdered in cold blood? Those who assaulted people should be arrested so that we militate what has come of Zimbabwean elections. We should move from that culture to genuine transitional justice.

FR: What is your assessment of the constitution reform process?

TM: Our position is simple, it is take charge. We are determined to the point where the knife meets the meat. This is not an NCA campaign but an NCA, ZINASU and ZCTU campaign. Today in 2010 we celebrate the ideals that define the principles of our struggle. We stand guided by the


Working People's Convention of 1999, and the civic charter of 5 June 2009 and I quote, "A genuine people driven constitution making process which is not politician or parliamentary driven but that which is presided by an independent commission". This is a simple rejection of the blatantly flawed COPAC process which is politician driven. Today we are celebrating the steadfast commitment to our principles that ZINASU will embrace a people driven constitution. The COPAC failure is enough testimony to the ZINASU octopus that COPAC will never succeed. So we are simply going to vote no, whatever the outcome because people have been coached on what to say and have been harassed and subjected to violence. ZINASU is different from fly by night politicians who lack commitment to principle. The MDC and its leadership says no to COPAC in the morning, says yes at lunch and say no once again in the evening. No one can be sure of their position when they take to bed. The PM was quoted as saying we will negotiate, probably its the Kariba document.

FR: What is your message to students?

TM: My message to the students of Zimbabwe is that we are not far away from making history. If the students in South Africa during the time of Steve Biko fought to a point where the knife met the meat, how can we fail ourselves?
