C.C.D.Z intensifies outreach work in Masvingo districts

n the month of December 2011, with five activities mainly targeted at Masvingo districts. C.C.D.Z continued with its community outreach programme, updating Zimbabweans on the current Constitution Making Process, the implementation of the Global Political Agreement as well as Minimum Conditions of a Free and Fair Election. An average of 150 people per each gathering attended the meetings. The decision to increase CCDZ's work and presence in Masvingo is informed by reported cases of increased intimidation led by war veterans and ZANU PF activists.

The meetings were held in Gutu. The first three meetings were held in Gutu at Matizha, Maungwa and Chisheshe Shopping Centers. The other two were held in Masvingo high density suburbs, Rujeko Township with the last one being held at Chivi Growth Point. C.C.D.Z worked alongside Community Based Organizations which include Masvingo United Residents Association (MURA), Chivi Residents Association (CHRA), Gutu Youth Forum and Community Tolerance, Reconciliation and Development (COTRAD).

Several issues arose during these civic discussion meetings. On polling station-based voting, there was a general fear that citizens will be vulnerable to retribution by losers in their constituencies. The issues of continued harassment and intimidation were topical. The participants also spoke about the importance of an independent electoral body to run the elections and expressed doubt about the independence and capacity of the Zimbabwe Electoral Commission to deliver credible elections. Similarly, the demand for a professional and non-partisan security sector as well as unbiased and informative media was very prominent.

The issue which however took centre stage was that of the neglect ion of the people in the province by the political leadership. An elderly woman at the Chivi meeting expressed her disgruntlement with the status quo saying that the political leaders have neglected the people who voted them into power. She said politicians elected into office by the people must always serve the people saying in Shona, kana muchida zvedu tipeiwo (if you want good things from us then do the same to us as well).

Most of the participants who attended the meetings professed ignorance about the Constituency Development Fund (C.D.F), with some saying they only heard of it in the media when the budget was announced." *Takangoihwavo ichitaugwa navaBiti pabudget, zvakahoitika sure kwazvo ndimi munoziva, dzimwe nhambo mari yacho ichi muzhira kuuya.Zvizhinji haikona zvinongopererako, kuno mounza mafufu,* (We just heard about it when Minister Biti was announcing the

budget) said Mrs. Masekesa, a prominent human rights activist in Rujeko Township.

With regards to public hearings on The Electoral Amendment Bill, CCDZ noted that 87 % of the people who attended the meetings did not participate in the process. Councilor Adrian Mazambani of Gutu South Ward 8 explained that, they only got the message about the hearings on the eve of this programme. He complained that besides being denied information by political opponents, there are some officials within the same political parties who also sit on information for their own selfish gains and millage.

One old woman in Chivi whom we cannot name for her safety said that she did not personally go because her views will not be taken seriously. We have said many things which we want our leaders to do but to no avail, she said. This view was also echoed in Rujeko Township and at Gutu where participants stated that political tensions were high during the Constitution Making Outreach hence they were afraid it could happen again, maybe this time resulting in an increase in violence.

Meanwhile, the people in Masvingo generally CCDZ for establishing Community Working Groups (CWGs) to spearhead local-level/community organizing. "This allows having meaningful and appropriate programmes based on knowledge of the place, contrary to a situation whereby people just come from any other part of the country to impose their programmes." said Mr. Matubvunye, a member of Chivi Residents Association.

Communities get raw deal from politicians

In the months of December 2011 and January 2012 as CCDZ was embarking on the project on: 'Capacity Building of Grassroots Communities and local leadership', two main problems were raised by communities. These are lack of consultation of communities and partisan distribution of resources earmarked for the community.

There was a unanimity over the imposition of ideas and implementation of projects by local leadership which include counselors, chiefs, Members of Parliament and village heads. The most astonishing was the revelation in Chirumanzi's Gambiza area where citizens were just called to receive cotton seeds despite the fact that their land is not suitable for cotton farming.

In Godzi Village, Chiweshe, one elderly man narrated that their community was not informed about Constituency Development Fund(CDF); they were just invited at Gweshe Secondary School where some buildings had been roofed whilst desks were bought using the stated funds. "They should have consulted us before doing that. What if we wanted a dip tank first?", said the elderly man.

In all the areas visited by CCDZ in Mashonaland West, Central and East provinces, citizens were complaining that the council just imposed a three dollar annual tax fee per household. There were also widespread complaints that citizens were not invited for the budget meetings. "Two or three people who work for the council just sit down and come up with a budget, maybe according to what they read in their books whilst at school", said one headman in Doro Village, Hurungwe. About 69 % of the people who were asked about the supposedly consultative processes such as public hearings on the Electoral Amendment Bill, Constitution Making Process and local government, expressed ignorance about those processes and issues at stake.

It also emerged that most things which are supposed to help communities are being distributed on partisan lines. These include agricultural inputs, food and even anti-retroviral drugs. The agricultural inputs are going to communities courtesy of The Presidential Input Scheme, nonetheless only ZANU P.F supporters are benefitting. In Karereshe Village, Karoi, perceived MDC-T supporters were reportedly told to source their own resources from the West who are their masters.

The food being distributed by NGOs such as World Vision, Care International and Catholic Relief Services is also reportedly being hijacked by politicians. The fertilizer and seeds provided by government through the Grain Marketing Board (GMB) in areas like Muzarabani, Mutoko, Murewa, Uzumba, Marondera, to mention a few areas has benefitted mostly ZANU PF members.

One common thing in all these instances is the fact that usually there is friction between ZANU PF local leadership and M.D.C-T leadership. For example in Magunje's ward Budwell Chasara 23 the Member of Parliament Hon Toro Chambati was voted on M.D.C-T ticket whilst the counselor,Clr Chasara is ZANU PF. In some constituencies were ZANU PF councilors were trounced they are still being recognized as winners and do have more control since they have access to resources. They can also hold meetings whenever they like compared to MDC-T officials .In constituencies where there is an MDC-T councilor, citizens are not allowed to attend meetings called by the councilor as they are deemed MDC-T meetings.

CCDZ holds strategic plan

CCDZ held a strategic planning workshop in early January 2012. The participants included CCDZ Community Working Groups, secretariat and board of governance.

The workshop was meant to map the way forward for CCDZ for the next 3 years (2012-2014) with the main objectives being to define CCDZ's strategic direction as well as to identify key strategic issues, to further improve the profile of the organisation, to forge strategic partnerships and strengthen the existing ones, to further improve the CCDZ resource mobilisation and management strategy. At the workshop, CCDZ revisited its mission, vision, values and goal.

CCDZ came up with four main programmes namely:

- i. Civic Participation and Education Program
- ii. Service delivery program
- iii. Peace building program
- iv. Livelihoods program

Among the key resolutions it was agreed that: Gender and the environment will all be mainstreamed in all the programs. This has been necessitated by the lack of participation of women in governance issues and the continuous degradation of the environment. There was also consensus on complementing the efforts of fellow civic society organizations and other stakeholders in promoting citizen participation in national development. It was also emphasized that CCDZ's programming will be incomplete without livelihoods projects as it is key in developing communities.
