Chiefs, headmen blasted

Communities around the country have lamented the selfishness of traditional leaders who recently demanded hefty allowances, guns, vehicles, boreholes and control of Constituency Development Fund (CDF).

Philip Pasirayi, the Centre for Community Development in Zimbabwe (CCDZ) Director said," communities recently visited so far-Mashonaland West, East and Central, Masvingo and Midlands-felt that the chiefs' demands were too personal."

"In recent CCDZ community meetings held on local government and service delivery, attended by an average of 100 people per meeting, participants felt chiefs were not doing anything spectacular that warrants those hefty allowances," said Pasirayi.

One youthful participant at Murereshi Village in Magunje said," the chiefs only desired material things while on the ground they were doing a shadowy job."

Participants in Chiweshe's Gweshe area lambasted the move as well, saying that," a good chief is protected by his own people and they can only fight him in the event he was not serving the people well."

In further questioning the reasons why there is a feeling that chiefs were performing below standard, it came out that," most of them have since become enemies of their own people, particularly those who do not support ZANU PF,"said the CCDZ director.

A young woman in Doro Village, Under Chief Dendera said, "We always get threats that we will be displaced from this area for supporting MDC and we are excluded from some provisions distributed by chiefs."

Pasirayi said," the majority of participants also complained about the bungling by minister of local government, Ignatious Chombo in community related issues."

This was mainly raised in Murehwa where the minister is said to have told the citizens that ,"chiefs had the rights to do whatever they deemed necessary in the communities since they were the custodians," he said.

Pasirayi said in Chirumanzi South, "Chief Nhema was urged to displace Tendekai Mugova, a youth who had exchanged harsh words with the chief at a beer hall."

The village heads have also been painted with the same brush with communities accusing them of being partisan.

An alarming revelation by communities in Chivi was the fact," that almost all village heads supported ZANU PF", said Pasirayi.

A village head at a CCDZ Community meeting in Chivi hastened to defend that position arguing that they were intimidated into doing so. "We are forced to act as such (being partisan) because failure to do so risked

either being removed from your position or being beaten up.

Pasirayi said," it became apparent from the meeting s that the headmen were actually involved in mobilizing people for political meetings."They were blamed for giving updates of what was prevailing politically in their respective communities to the ZANU PF leadership.

Women lamented their discrimination at the hands of chiefs. Chief Nyakunhuwa, whose chieftainship in Zaka was mentioned, having said that the role of women was just to assist men as they instructed them, said the CCDZ leader. CCDZ Information Officer, George Makoni said they assured the villagers that their concerns about partisan traditional leaders would be raised at government level.

We want to assure them that we will raise their concerns with the inclusive government.

Traditional leaders are not supposed to behave as political commissars of political parties, "said Makoni.

He however added that in some areas CCDZ was working with progressive chiefs who were sticking to their role as custodians of culture and not mixing that with politics in violation of Article 14 of Global Political Agreement.



Chimwe change chichitosvora vanhu munzvimbo zhinji idzi zvakare, kusasumwa kwevanhu zvinoda kuitwa nekumbonzwawo pfungwa dzavo.Kune dzimwe nzvimbo vanhu vaingokaruka zvonzi tovaka dhibha, asi ivo vanhu vaine pfungwa dzekuvaka zambuko. GNU urged to curtail excessive powers vested in Local government Minister

The Centre for Community Development in Zimbabwe (CCDZ) expresses its disappointment and concern over recent developments by the Minister of Local Government which serve to militate against positive service delivery in urban and rural councils.

It is clear that Minister Chombo is targeting MDC councils that he wants to neutralize ahead of the planned elections in 2012/2013. Although there might be genuine cases of corruption involving these officials, it is baffling why it is only officials from one political party in the inclusive government that are targeted. There is urgent need for reforms in local government to rid it of partisan interference. The imperial powers vested in the Minister must be curtailed. There are plenty of suspected/reported cases of corruption in ZANU PF-run councils which are never investigated.

In almost all rural communities where CCDZ is working there are reports of ZANU PF councilors diverting agricultural inputs for their own benefit at the expense of the intended beneficiaries; the communities Minister Chombo is also deliberately disregarding the people's will by using imposing the so-called 'Special Interest' councilors in wards where MDC-T won.

Equally worrying is the Ministers interference with traditional leaders. CCDZ notes with great alarm the unilateral the installations and removal of chiefs and the creation of new Headmen and Village Heads in former commercial farming areas.

The Minister has also announced that the Ministry of Local Government will in the next eight months create new boundaries for chiefdoms. Given the already partisan approach to local government issues, there is a possibility that this is a deliberate political move to give chiefs who support ZANU PF an advantage over those perceived to be MDC. In light of this, CCDZ takes this as defacto delimitation ahead of the impending election. Delimitation of constituencies is the purview of the Delimitation Commission as per the Electoral Act. The Minister of Local Government is acting ultra vires powers by tampering with traditional chiefdom boundaries to give ZANU PF an electoral edge over other parties.

We suspect that the distribution of blankets, food, agricultural inputs and the electrification of chiefs' rural homesteads could be a ploy to 'buy' the loyalty

of chiefs ahead of the next elections. This would be in violation of the Traditional Leaders Act which stipulates that chiefs should not be involved in political matters.

During CCDZ activities, community members have reported that the so-called 'Special Interest Councilors' are being used for partisan purposes by Minister Ignatius Chombo. Others have gone as far as alleging that the Special Interest Councilors have become more powerful than the elected councilors. CCDZ urges these Councilors to invest their energy into solving the day to day problems which affect ordinary Zimbabweans such as the recent typhoid outbreak and other critical service delivery issues; rather than to meddle in petty political ploy.

CCDZ would also like to express its concern over the increased harassment of vendors and small scale business owners with links to political parties. Given the current estimated 80% unemployment rate, such actions have the same effect as Operation Murambatsvina in that they seek to destabilize the livelihoods of Zimbabweans who are not in formal employment.

It is our hope that the Second Draft Constitution of Zimbabwe will contain progressive provisions which constitutionalise local government matters and protect it from partisan interference by the Minister.

Press Release: NGO BAN IN MASVINGO RETROGRESSIVE

The Centre for Community Development in Zimbabwe will not stop its operations in Masvingo province or any other part of the country as long as government lacks capacity to provide better social services to the citizens. We are not surprised by the move taken by the ZANU PF leadership in Masvingo led by Governor Titus Maluleke to ban NGO operations in the province as this has happened in the past especially each time that an election looms.

Similar attempts by the government in 2004 when government drafted the NGO Bill to proscribe the operations of human rights and governance NGOs did not go any far because beneficiaries always co-operate with NGOs in the wake of government's lack of capacity to provide food, health and other social services.

CCDZ will continue to work in Masvingo to provide non partisan education and raise awareness on citizen rights. CCDZ is also working in the following districts: Bikita, Chivi, Nemamwa, Gutu and Masvingo urban and rural on peace-building and preparing communities ahead of the planned constitutional referendum and elections.

We are surprised that Governor Maluleke made the announcement that he was banning NGOs in Masvingo whilst he was flanked by members of the security services. We reiterate our calls that the inclusive government should not politicise the work of NGOs. The NGOs are doing fundamental work to complement government's efforts to deal with poor service provision and to promote peace in the rural areas following the violent and divisive politics of

the past years that has left most of our communities deeply polarized. We urge the ZANU PF officials in the inclusive government to respect the Global Political Agreement (GPA) especially art. XVI on the role of NGOs in humanitarian and food assistance.

Governor Maluleke is being hypocritical to ban NGOs in a province in which more than 70 percent of the people are starving due to food shortages. The governor should be wise enough to invite more NGOs to help ameliorate people's suffering in Masvingo rather than squeeze out the few that are operating in the province all for political expediency. What is also baffling is that the governor and securocrats who flanked Maluleke did not take action against Jabulani Sibanda, the war veterans Chairman who has been terrorising people in Masvingo province.

The attempt by ZANU PF officials in Masvingo to ban NGOs ahead of the elections is undemocratic. We want to assure the people in Masvingo that we will continue with our work and urge more people to participate in our programmes.
