Zimbabwe dominant political party, ZANU PF is increasingly under pressure from its military and security sector backers who are slowly but surely taking over the party. Reports from all of Zimbabwe's provinces indicate the active participation of the security sector in deciding who occupies what position in ZANU PF's District Coordinating Elections (DCC) as well as the filling of vacant positions at provincial structures. The participation of the security sector has added a new dimension to Zimbabwe's politics as there is intense infighting for key positions with the security sector playing the role of kingmakers and also fielding its own candidates from former army generals, colonels, police commissioners to Intelligence officers. The power struggles in ZANU PF are over the succession of Robert President Mugabe, whom, despite official denials is frail and certainly on his way out. By his own admission, Mugabe is not grooming anyone to take over the party leadership nor is he interested in that idea. His intention to die in office has, jockeying by his juniors, both in the party and security sector, to position themselves for takeover.

health. So whether he likes it or not, the vultures are already circling over Mugabe's party seat and hoping to still win national elections by hook or crook and maintain ZANU PF's political hegemony. no-one wants to be left out of vance partisan political interests. This is not new as the security sector has always supported ZANU PF and abused state resources, but now they are not looking at supporting ZANU PF but taking over ZANU PF and state control.

> Zimbabwe is undergoing probably one of the most long drawn military takeover processes. The security sector is working to finalise its project of taking over the country under the guise of reforming ZANU PF. In this instance the danger to us all is that the security of citizens is put under severe threat. Essentially Zimbabwe no longer has independent state security organs but party aligned state organs. The laws of the country that include the Defence Act are being trampled upon with impunity. Added to this, the security sector is opposed to the ongoing constitutional process hence likely to exert pressure on Mu

gabe to reject the draft constitution or to use the delays in finalising the document to pull out of the Unity Government and call for elections.

Elections under Mugabe are desired by the security sector as they would outflank the ZANU PF old Guard by asking Mugabe to anoint one of them after his planned electoral 'win'. The question is would Mugabe anoint a security sector candidate be it the Army Commander Constantine Chiwenga or another civilian military face chosen by the security sector? The answer is still very much up-in the air, but in the current circumstances, only then security sector can guarantee the security of Mugabe and that of its leadership and their ill-gotten wealth. At the end of the day, it is the security sector that is going to decide who comes in as ZANU PF leader anywhere because of their leverage to guarantee security to the politicians in ZANU PF. In other words the ZANU PF politicians are being asked to step aside and continue to enjoy the loot. Once again civil society must be fully awake to this danger which cannot be underestimated.

The regional body, SADC and the international community will be called to maintain pressure on Zimbabwe to ensure that the infighting in ZANU PF, small as it might appear, does not engulf the whole country and spill over into the region. In these circumstances the call for elections in 2011, is a process of certifying and legitimising a plan already in place that is a 'win' by Mugabe followed by the anointing of a military chosen successor. The chickens are finally coming home to roost for those ZANU PF politicians who gloated over the support of the military in supressing other parties and civil society. Yet the crisis over security for all of us is far from over, and might as well be beginning in another far dangerous and hideous format.

Pastors' Prayers for Peace Initiative Stirs Hope

Last Saturday pastors under the auspices of the Zimbabwe National Pastors' Conference convened a National Prayer for Peace Day at Mkoba stadium in Gweru attracting close to 15 000 participants from Gweru and surrounding grassroots communities. Prime Minister Morgan Tsvangirai dressed the prayer meeting representing political principals in the Inclusive Government. Similar prayer for peace meetings were held in Chitungwiza, Masvingo and Mutare and there are plans to host such meetings in Bulawayo and Harare this month.

PM Tsvangirai echoed president Mugabe's Independence Day message of peace and urged the thousands of people attending the rally to promote peace and to 'love thy neibhour as you love yourself.' The significancy of the prayer for peace meetings lies in their ability to stir hope for a better, more secure future for the people of Zimbabwe. It is commendable that PM Tsvangirai and President Mugabe have verbally committed themselves to promoting peace, but it is not enough. To banish the ugly culture of violence that has characterized Zimbabwe politics in the last decade, it is necessary to cultivate a culture of openness where Zimbabweans from all walks of life, particularly grassroots communities, are able to publicly denounce violence without fear.

Violence and fear are the twin plagues that must be confronted from a nonpartisan platform best provided by the churches. Churches have been blamed for promoting a spirit of docility and uncommon submissiveness in the face of extreme oppression that Zimbabweans has suffered perhaps it will be the churches that will lead in rallying Zimbabweans to promote peace as a confidence-building measure that will ultimately contribute to the removal of violence and Zimbabweans fear. All should join in the call for sustainable peace and take action in their communities to ensure the maintenance of peace.

Political principals and Inclusive Government leaders must, however, go a step further than simply calling

for peace to prevail, they must direct state institutions responsible for the maintenance of peace, law and order to act impartially, professionally and independently in the discharge of their duties. The message must ring loud and clear that violence does not pay, but rather, that there is a high price to pay for committing violence or other human rights abuses. Political activists or state agents who commit violence, or political leaders who urge or conspire to commit violence must face the full wrath of the

cases of violence committed around the 2008 elections that have largely gone unpunished because of partisan policing. But as the ICC's action against Taylor has shown, where domestic justice remedies have failed, there are international instruments that can be effectively used to achieve justice.

The ongoing prayer for peace meetings across the country are also of critical importance in that they are providing a platform for Zimbabweans from diverse

law. The recent conviction of former Liberian leader Charles Taylor by the International Criminal Court (ICC) at the Hague is a telling example.

There has been easy resort to violence by political activists to achieve political ends primarily because the police had generally abdicated on its responsibility to ensure personal security for Zimbabweans regardless of political affiliation as exemplified by the hundreds of

political backgrounds to once again get used to peaceful public interaction which in turn acts as a confidence building measure that, although it is a difficult transition, Zimbabwe is certainly changing for the better. The merchants of violence, chaos and confusion, although vocal, are now few in numbers - they are overwhelmingly outnumbered by peace-loving, law-abiding and kind Zimbabweans. The small challenge is for the majority of peace loving Zimbabweans to stand up and be counted.

The more people speak out for peace, the less the fear of victimization and the higher the chances that even more people will join to take charge of their lives by taking part in various peace initiatives in their communities. As the draft constitution is getting ready for debate within further communities people must come out and speak freely about the need to promote peace, basic freedoms and personal security and to have those values reflected in the new constitution.

The message of peace, nonviolence and respect for basic rights is a message that unites us as Zimbabweans. It is a message that should find resonance in the church, in the pub, in Zanu PF, in MDC, in ZAPU and in any other formation or grouping. It is no longer time to be fearful; it is time to boldly proclaim the our determination as a people to build a society free of violence, fear, intimidation, hatred, patronage and corruption. The sacrifices made by thousands of Zimbabwe's

gallant sons and daughters during the liberation struggle were not so that we live in fear and with a sense of victimhood, but that we enjoy freedom, development and peace in abundance.

Aspirations for peace, independence, equal protection of the law and ending polarization, divisions, conflict and intolerance are non-partisan. All Zimbabweans regardless of political affiliation should embrace the message of peace and actively support initiatives to bring lasting peace to Zimbabwe. The surest

way to give the people of Zimbabwe a genuine chance of rebuilding and reconstructing their livelihoods begins with the removal of fear through an active, public promotion of peace. The pastors prayer for peace meetings are greatly appreciated because they keep hope alive that Zimbabwe will not return to the dark age of chaos, anarchy and violence.

MDC Youth Assembly President's Message to the Youth of Zimbabwe in the Mouth of Independence, April

I would like to congratulate Zimbabwe for attaining 32 years of independence. Thirty two years on, it is paradoxical that I am writing to you from what has been my home for the past seven months: My 1,5m x 3,5m holding cell at Chikurubi Maximum Prison. My innocent colleagues and I are here because we have said enough is enough Mugabe Must GO! So how is our spirit and determination to go forward with the struggle? We are stronger than ever before. I am greatly humbled by the unwavering support and solidarity that you have continued to show. Indeed I am profoundly moved, I urge you to keep up the spirit. My colleagues and I are sincerely grateful.

I want to take this opportunity to reflect on the essence of the liberation struggle:

Zimbabweans united and waged

a protracted and excruciating struggle against the settler regime in pursuit of majority rule, one man one vote and the resolving of the land question. This has however unfortunately been raped. What is in doubt today is whether majority rule as a tenet and practice of democracy and good governance is still being practiced. Are Zimbabweans freer now under the leadership of Robert Mugabe than they were under Ian Douglas Smith and his Rhodesian Front? It is unfortunate that land, our land which was the major motivation behind the struggle for liberation, was parceled out to some few people using ZANU PF's patronage system, given on partisan lines, when indeed all Zimbabweans participated in the liberation struggle.

Indigenization and economic empowerment

In the subsequent, a patronized asset stripping and plunder spree reminiscent of the reckless land seizures and destruction of the agricultural sector which had been the backbone of our economy, has been packaged as indigenization, without clear policy framework, to perpetuate looting.

Justice System

Sons and daughters of Zimbabwe have been reduced to mere subjects of abject incarceration and persecution in the hands of a defective justice system presided over by power mongers and overstaying oldies, bent at silencing genuine voice of dissent.

The security sector

The patronage system by Mugabe is clearly visible and hinged on the way the Zimbabwe Security forces are run. All the security arms' leaders exude an archaic and corrupt way of dealing with citizens perceived to be opponents of the ailing commander in chief. There seems to be a mentality of being immortal and "foreverness" among those leading these forces.

The people of Zimbabwe surely deserve a lot better. I would like to resolutely urge fellow youth and Zimbabweans to ensure that we reclaim what is rightfully ours. Our determination and conviction to see a better Zimbabwe for all must be our driv-

and predictability and political stability and the protection and furtherance of democratic institutions.

COPAC submitted the First Draft of the Constitution of Zimbabwe to the Management Committee. The Management Committee endorsed the draft constitution and the draft is to be submitted to the Principals by the fifth 5th of May. CO-PAC has only managed to deal with a few issues in dispute, for instance citizenship and death penalty leaving the rest to be dealt with by a new government that will emerge after the next elections.
