## **DISCUSSION:**

The two authorised sales of Marange diamonds in August and September 2010 make clear the Zimbabwe government has no reason to feel threatened by a Western diamond import ban. In the diamond world, too, emerging powers are challenging the rules and becoming more influential. Buyers, especially from India have been more than willing to fill the gap resulting from the absence of most Westerners. Chinese buyers could also potentially compete, since Beijing joined New Delhi in strongly urging that the export ban be lifted during the negotiations leading to the St. Petersburg compromise. With world production falling by 24% since 2009 and increased competition, buyers are becoming readier to push human rights and governance standards aside. Marange is already a major producer, and new deposits are still being discovered in the country, so Zimbabwe's importance as an exporter is likely to grow.

The regulator role of the Kimberley Process is being challenged. This is all the more so in situations where, as in Zimbabwe, it actually has no legal basis to ban diamond exports, but has to rely on the voluntary agreement of the diamond exporting government. In fact, expelling Zimbabwe from the KP scheme as has been suggested by civic groups, may not legally be possible and, in any event, might only allow new actors, such as Indian diamond buyers, to push more aggressively into the market without any human rights consideration.

The Marange affair reveals two contradictory trends: the emergence of new voices within an industry previously dominated by one major company, De Beers, and the politicisation of the KP. While the KP was established only to prevent rebel groups from profiting from diamonds, some have suggested extending the definition of conflict diamonds to take governance issues (such as corruption, political oppression and violence) into consideration.

This would shift the focus of the Kimberley Process. The question is whether authoritarian regimes under international sanctions such as Zimbabwe should be prevented from using diamonds as a financial lifeline or whether only rebel groups should be targeted.

## **COMMENTS ON THE KIMBERLEY PROCESS**

"The KP has to make decisions about the conflict diamond definition, about how to improve transparency in the industry (for instance requiring full disclosure of contracts), about how to adjust to the industry's new configuration and above all about the political issues behind the diamond trade. Otherwise, it risks becoming increasingly irrelevant."

"We all agree that nobody should violate human rights in any place in the world, but the job can't be placed on the shoulders of the Kimberley Process. We must tell the truth, loudly and clearly: We have neither the tools nor the ability to handle this very important issue. The Kimberley Process cannot resolve all the world's problems or achieve goals that extend far beyond its definition as an effective barrier to trade in conflict diamonds."

Israel Diamond Institute chairman and Israel Diamond Manufacturers Association president, Moti Ganz. He explains <u>his personal involvement</u> in the struggle to release rough export from Zimbabwe in his article posted on 9 January 2011:

"We cannot turn the Kimberley Process into an NGO, into some kind of UNESCO, or some kind of human rights enforcement or monitoring organization. We don't have the capacity for that; we don't have the skills for that; and we don't have the expertise to do so.

The Kimberley Process, at the end of the day, is a kind of customs union enabling the smooth flow of clean rough diamonds certified by legitimate and sovereign governments. The Kimberley Process is not the right body to identify, quantify or remedy human rights violations.

Producers realize that we are their natural allies. Let me be clear, I do not see another option for any producer but to fully implement the KPCS rules and regulations. It would bring a catastrophe to our diamond industry if even one producer worked outside the KP system. That's why I became so deeply involved, on your behalf, in the Zimbabwe imbroglio. An agreement on Zimbabwe diamonds would be good for the industry, for the KP member countries, for the NGOs and, especially, for the citizens of Zimbabwe. All parties must go that extra mile, even if it means further concessions, to protect the interests of the diamond industry, which provides a livelihood for so many families in the world. This is what has guided my involvement in the KP for the past year."

Ultimately, the core question is whether the Kimberley Process continues to have any effectiveness or relevance in addressing today's trade in conflict diamonds. Sarah Logan: "The Treasure and Tragedy of Marange", 11 July 2011
